Subject:- RECRUITMENT TO (191) ONE HUNDRED AND NINETY ONE (INCLUDING 16 POST RESERVED FOR SPECIAL PERSONS AND 10 POSTS RESERVED FOR MINORITY QOUTA) POSTS OF MEDICAL OFFICER (BS-17) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN THE (PUNJAB EMPLOYEES SOCIAL SECURITY INSTITUATION) PUNJAB LABOUR & HUMAN RESOURCE DEPARTMENT.

#### **PRESCIBED QUALIFICATION OF THE POST:**

MBBS with one year House Job duly recognized by PM&DC.

**AGE LIMIT:-** Male: 23 to 45 + 05 = 50 years

#### **CLOSING DATE:-**

The following original documents are required for eligibility/scrutiny criteria to the post of **Medical Officer (BS-17):-**

- 1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
- 2. Original Certificate of Matriculation /O Level showing date of birth Obtained/ Total Marks.
- 3. Certificate of Intermediate / A Level showing date of birth Obtained/ Total Marks.
- 4. Original Degree of MBBS including all professionals of MBBS Detailed Marks Certificate showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
  - **a.** Detailed Marks Certificates (DMCs) of all professionals of MBBS and relevant mentioned degree issued on or before the closing date showing obtained/total marks or Percentage Certificate from the Controller of Examinations is mandatory in case the candidates have degree with only CGPA as PPSC does not accept CGPA.
  - **b.** In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Interview from PMDC/PMC or QEDC of concerned Administrative Department.
- 5. One year house job duly recognized by PM&DC.
- 6. i) Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission issued on or before the closing date.
  - **ii)** Candidates who had applied for renewal of their expired registration after the closing date shall also be held eligible.
- 7. Domicile Certificate issued on or before the closing date.
- 8. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
- Disability Certificate from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
