Law Graduate from recognized university with Two Years legal practice.

- **6.** Experience certificate showing exact dates & containing complete information from President District Bar Association duly countersigned and affixing rubber stamp of District and Sessions Judge/Addl. District and Sessions Judge concerned (in original) also having Enrollment Certificate as an Advocate issued by the Punjab Bar Council shall be submitted at the time of interview.
- 7. Certificate of Physical Standard issued by the Medical Superintendent of District Headquarters Hospitals or Service Hospital, Lahore or Police Hospitals shall be accepted under the Regulations/Policy Decisions.
- 8. Treasury Receipt of Rs.1000/- deposited upto the closing date i.e. -2022.
- 9. Domicile certificate issued on or before the closing date or in case Domicile Certificate is issued after the closing date documentary evidence for submission of application for domicile, before closing date to the issuing Authority.
