#### **GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA**

#### **RECRUITMENT TO ONE (01) POST OF ASSOCIATE PROFESSOR OF** PAEDIATRIC OPHTHALMOLOGY (BS-19) ON REGULAR BASIS IN SPECIALIZED HEALTHCARE & MEDICAL THE **EDUCATION** DEPARTMENT.(41-RF/2023)

## Prescibed Qualification of the Post:

a) MBBS or equivalent qualification recognized by the PMDC / PMC. Registration with PMDC / PMC.

The following postgraduate qualification:

i) FCPS / MS / FRCS / Diplomat American Board in Paediatric Ophthalmology or equivalent qualification recognized by the PMDC / PMC.

OR

- ii) FCPS / MS / FRCS / Diplomat American Board or equivalent qualification recognized by PMDC / PMC in Ophthalmology with one year experience after post graduation in the Paediatric Ophthalmology in an institution recognized by PMDC / PMC.
- b) Five (05) years teaching experience as Assistant Professor in the speciality or an equivalent position recognized by PMDC / PMC.
- c) At least three research papers published in the standard Medical Journal recognized by the PMDC / PMC while working as Assistant Professor.

## Age Limit till closing date:

Male Candidates:	30to 50 + 5 = 55 years
Female Candidates:	30 to 50 + 8 = 58 years

The following original documents are required to determine the eligibility of the candidates for the post of ASSOCIATE PROFESSOR OF PAEDIATRIC OPHTHALMOLOGY (BS-19):-

- 1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
- Original Certificate of Matriculation / O-level showing date of birth, 2. obtained/total marks.
- Original Certificate of Intermediate / A-level showing obtained/total marks 3.
- 4. Original All Prof. of MBBS issued by the Controller of Examinations from the university recognized by the HEC.
  - Detailed Marks Certificates (DMCs) of all relevant mentioned degrees a. issued on or before the closing date showing obtained/total marks or Percentage Certificate from the Controller of Examinations is mandatory in case the candidates have degree with only CGPA as PPSC does not accept CGPA.
  - In case of equivalent qualifications, it will be responsibility of the b. candidates to obtain equivalence of their degrees to the required

qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Administrative Department.

5. FCPS / MS / FRCS / Diplomat American Board in Paediatric Ophthalmology or equivalent qualification recognized by the PMDC / PMC completed on or before the closing date of Advertisement. OR

FCPS / MS / FRCS / Diplomat American Board or equivalent qualification recognized by PMDC / PMC in Ophthalmology with one year experience after post graduation in the Paediatric Ophthalmology in an institution recognized by PMDC / PMC.

Experience Certificate(s) issued by Competent Authority as per requirement. (in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).

Only Teaching / Practical experience after the prescribed qualification shall be considered. In case of experience gained from private entities, proof of registration of that particular entity with Punjab Medical Commission / Punjab Medical and Dental Council or any other regulatory authority is required for the period during which experience was gained by the candidate. Experience gained on OPS (own pay & scale) shall not be accepted after 17-06-2021.

- **6.** Original Domicile Certificate of any district of the province of Punjab issued on or before the closing date.
- 7. Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.
- **8.** Five (05) years teaching experience as Assistant Professor in the speciality or an equivalent position recognized by PMDC / PMC with at least three research papers published in the standard Medical Journal recognized by the PMDC / PMC while working as Assistant Professor.
- **9.** Acceptable Original Research Papers as described in qualification stated above.
- 10. Departmental Permission Certificate on prescribed proforma of PPSC-5 duly signed & stamped by the Appointing / Competent Authority in case of Government Employees / Semi or Autonomous bodies.
- **11.** Equivalence Certificate of qualification from HEC / QEDC of the concerned Administrative Department as the case may be.

**12.** Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
