#### Subject: <u>RECRUITMENT TO ONE (01) POST OF PRINCIPAL, (BS-18)</u> <u>POLICE DOG BREEDING CENTRE & TRAINING SCHOOL,</u> <u>SPECIAL BRANCH IN PUNJAB POLICE DEPARTMENT</u> (CASE NO. 46H2022)

#### **QUALIFICATION:**

Doctor of Veterinary Medicine alongwith Master's degree (M.Sc Hon/M.phil) in "Pet Animal Clinical Practice" or "Clinical Medicine" or "Clinical Surgery" or "Theriogenology" with at least three years' experience in canine practice and management.

Preference shall be given to those who have experience in Canine Training and Arms & Explosive Sniffing of Dogs.

#### PAY SCALE: BS-18

#### AGE LIMIT: Male Candidates:

**35 to 45 + 07 = 52** on **28-11-2022.** Female Candidates:

**35 to 45 + 10 = 55** on **28-11-2022.**

### **CLOSING DATE** 28-11-2022

The following original documents are required for eligibility to the posts of **PRINCIPAL (BS-18).** 

- 1. Valid CNIC
- 2. Certificate of Matriculation/O. Level
- 3. Certificate of Intermediate/A. Level
- 4. Bachelor degree/ Transcript/ DMC showing total marks & Obtained marks/ percentage of marks issued by the Controller of Examination of College/University.
- 5. Master degree/ Transcript/ DMC showing total marks & Obtained marks/ percentage of marks issued by the Controller of Examination of College/University.
  - 6. In case of post-graduate degrees, the PVMC Certificate should mention all the degrees acquired by the candidate.
  - Experience in private entities shall be accepted if such entity is registered with Securities & Exchange Commission of Pakistan, (SECP) Registrar of Firms or any other Regulatory Authority.
  - 8. Only Practical Experience after prescribed qualification shall be considered.
- 9. Candidate shall produce certificate of valid registration of DVM with PVMC. In case of post-graduate degrees, the PVMC Certificate should mention all the degrees acquired by the candidate.
- 10. Treasury Receipt of Rs.600/- deposited upto the closing date i.e. **28-11-2020**.

- 11. Domicile certificate issued on or before the closing date or in case Domicile Certificate is issued after the closing date documentary evidence for submission of application for domicile, before closing date to the issuing Authority.
- 12. Departmental Permission Certificate issued by the Appointing Authority in case of Government employees.
