All bids must be accompanied by a Bid Security of 2% of the total bid price in the form of a CDR.

### 6. Procurement Procedure:

The procurement will be conducted as per the <u>Single Stage – Two Envelope</u> Procedure in accordance with Rule 38 of Punjab Procurement Rules 2014.

### 7. Bid Validity:

Bids shall remain valid for 90 days from the date of bid opening.

#### 8. Delivery Period:

 Successful bidder will have to Air Conditioner on stipulated period after issuance of Purchase Order (Supply Order) at consignee address.

#### 9. Currency:

 Rates should be mentioned in Pak Rupees with and without GST. However, GST will be charged separately.
