Prescribed Qualification

MBBS or equivalent medical qualifications recognized by the PMDC/PMC and the following postgraduate qualifications in the subject:

D.Sc, Ph.D, M.D, M.Phil (Pak); or equivalent qualifications recognized by the PMDC/PMC.

Credit will be given for original research work published in a standard medical journal and teaching experience in recognized institution.

AND

03 years teaching experience in the subject as Associate Professor or an equivalent position recognized by the Pakistan Medical and Dental Council (PMDC)/Pakistan Medical Commission in the basic specialties. Provided that the total teaching experience as Assistant/Associate Professor is not less than 08 years OR 09 years teaching experience as an Assistant Professor in the subject in recognized institution and at least 5 research papers published in standard medical journal while working as Assistant/Associate Professor.

Equivalent Qualifications, If any:

As recognized by the Pakistan Medical & Dental Council (PMDC)

Age Limit: Male: 30 to 50 + 5 = 55 years

Female: 30 to 50 + 8 = 58 years

The following **original documents** are required to determine the eligibility of the candidates for the subject post(s):-

- ii. Original Departmental Permission Certificate issued by the Appointing Authority (in case of government employees).

- v. MBBS (First to Final Professional) showing obtained/total marks or equivalent Medical qualifications recognized by PMC/PMDC.

- vii. Valid full (Permanent) Registration Certificate of PMDC/PMC showing all Medical/Dental Qualification(s).

- ix. Experience Certificate(s) issued by Competent Authority as per requirement.(in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).
- x. Letter of recognition of experience from PMDC.
- xi. Disability Certificate (in case of Specially-abled Person)
- xii. Equivalence Certificate issued by the Competent Authority (in case of possessing an equivalent qualification)
- xiii. Acceptable Original Research Papers as described in qualification stated above.
