- (i) MBBS or equivalent qualification recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council;
- (ii) Registered with Pakistan Medical Commission/Pakistan Medical & Dental Council ;
- (iii) FCPS, MD, MRCPCH, Diplomat of American Board in Paediatrics or equivalent qualification in Paediatrics recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council;
- (iv) Three years' experience as an Associate Professor Paediatric Medicine (BS-19) provided that the total teaching experience as an Assistant Professor (BS-18) and Associate Professor Paediatric Medicine (BS-19) is not less than eight years' in an institution recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council or nine years' teaching experience as an Assistant Professor (BS-18) or Associate Professor Paediatric Medicine (BS-19) in an institution recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council; and
- (v) Five Research Papers published as Assistant Professor (BS-18) or Associate Professor Paediatric Medicine (BS-19) and recognized the Pakistan Medical Commission/Pakistan Medical & Dental Council or the Higher Education Commission.

**Equivalent Qualifications, If any:**
