Prescribed Qualification

a) MBBS or equivalent medical qualification from an institute or a university recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council and FCPS or MS or FRCS or MRCP or MD or Diplomat of American Board in the respective specialty or equivalent medical qualification in the respective specialty from an institute or university recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council.

If none is available with above qualifications then:

MBBS or equivalent medical qualification from an institute or university recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council and FCPS or MS or FRCS or MRCP or MD or Diplomat of American Board (General Surgery or Medicine, whichever is relevant to the respective speciality) or equivalent medical qualification from an institute or university recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council with three years' post-graduation practical experience in the respective specialty from a recognized institute.

b) 08 years teaching experience as Associate Professor / Assistant Professor (in the speciality) in a recognized institution (03 years as Associate Professor and 05 years as Assistant Professor) OR 09 years teaching experience as Assistant Professor, in the speciality in a recognized institution with 05 research paper published in a Standard Medical Journal while working as Assistant / Associate Professor, in the speciality.

Equivalent Qualifications, If any:

As recognized by the Pakistan Medical & Dental Council (PMDC)

<u>Age Limit:</u> Male: 30 to 50 + 5 = 55 years <u>Female: 30 to 50 + 8 = 58 years</u>
