**17 posts of Consultant Urologist (BS-18) in the Punjab Primary and Secondary Healthcare Department**

The result of three (03) posts reserved for special zone quota has been withheld by PPSC due to judgment dated 11-06-2019 of Hon'ble Lahore High Court, Lahore in writ petition No. 257665/2018 titled as Dr. Shahbaz Mujtaba Ghauri vs ppsc etc. However, an I.C.A No. 39525/2019 filed by Dr. Anees ur Rehman against the said judgment is pending adjudication in Division Bench of Lahore High Court, Lahore. The said result will be announced after the final outcome of the aforementioned I.C.A.

- ii) Two (02) (including 01 post reserved for special persons quota and 01 post reserved for minorities quota) posts remained vacant due to non-availability of suitable candidates.
- iii) No Female candidates are available against the three (03) posts reserved for women quota for above said posts. Therefore, as per notification No.SOR-IV(S&GAD)15-1/2012 dated 21-05-2012, **three (03)** posts reserved for Female quota shall be treated as unreserved and filled on merit.
