Prescribed Qualification

- i) MBBS or equivalent qualification recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission;
- ii) Registered with the Pakistan Medical & Dental Council/Pakistan Medical Commission; and
- FCPS, MD, CCT, Diplomat American Board in Developmental-Behavioral Paediatrics or equivalent qualification recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission.

If no candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualifications recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission with one year experience in Developmental Paediatrics after Post-graduation in Paediatrics obtained in a training program accredited by a National Body (CPSP orUniversity) or an International Body from an institute recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission.

And if no candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualification recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission with two years' experience in Developmental Paediatrics after Post-graduation in Paediatrics from an institute recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission;

- iv) Five years' teaching experience as an Assistant Professor Developmental Paediatrics from an institute recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council; and
- v) Three research publications in Developmental Paediatrics, as Assistant Professor (BS-18) in a standard medical journal recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission or the Higher Education Commission.

Equivalent Qualifications, If any:

As recognized by the Pakistan Medical & Dental Council (PMDC)

Age Limit: Male: 30 to 50 + 5 = 55 years

Female: 30 to 50 + 8 = 58 years

- vi. Postgraduate degree/ diploma or its Transcript in the relevant specialty / equivalent qualification or its Election letter showing specialty as per advertisement.
- vii. Valid full (Permanent) Registration Certificate of PMDC/PMC showing all Medical/Dental Qualification(s).
- viii. Domicile Certificate of any district of the Punjab Province, issued on or before closing date of Advertisement.
- ix. Experience Certificate(s) issued by Competent Authority as per requirement.(in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).
- x. Letter of recognition of experience from PMDC (if possessed by the candidate).
- xi. Disability Certificate (in case of Specially-abled Person)
- xii. Equivalence Certificate issued by the Competent Authority (in case of possessing an equivalent qualification)
- xiii. Acceptable Original Research Papers as described in qualification stated above.
