Subject: RECRUITMENT TO 37 (THIRTY-SEVEN INCLUDING 01 POST FOR SPECIAL PERSONS, 02 FOR MINORITY QUOTA & 18 POSTS FOR **WOMEN QUOTA) POSTS OF SECONDARY SCHOOL TEACHER (BIOLOGY)** (BS-16) ON CONTRACT BASIS FOR A PERIOD FIVE (05) YEARS IN THE PUNJAB WORKERS WELFARE FUND, LABOUR & HUMAN RESOURCE **DEPARTMENT (53M2023 TO 65M2023).**

QUALIFICATION:

M.A./M.Sc. with B.Ed. or B.S. Ed.

For SSTs (Biology), M.Sc. in relevant subject.

- 1. Only those degrees which are recognized by Higher Education Commission will be accepted.
- 2. At least 2nd Division in the prescribed minimum qualifications is required.

AGE LIMIT:-

Male: 21 to 35+5 = 40 years

Female: 21 to 35+ 8 = 43 years

QUOTAS:-

The detail of open merit, special persons, minorities and women quota for the relevant case may be seen in the advertisement of the concerned post(s).

CLOSING DATE: 29-12-2023

The following original documents are required for eligibility/scrutiny criteria to the post of **SST (Biology) (BS-16)**:-

- Original Valid CNIC (It must not be expired on last day of applying online for the 1. subject post).
- 2. Original Certificate of Matriculation / O level showing date of birth Obtained/ Total Marks.
- 3. Original Certificate of Intermediate / A level showing Obtained/Total Marks.
- Original Bachelor Degree showing Obtained/Total Marks or Percentage Certificate issued 4. by Competent Authority.
- Original M.Sc. degree (2nd Division) or BS (2nd division) in the relevant subject showing 5. Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
 - 6. Candidates who do not possess the above said qualification will not be eligible even they had qualified Written Test.
 - In case of equivalent qualifications, it will be responsibility of the candidates to b. obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Administrative Department. However, a list of equivalent qualifications is ailable on the Commission's official website, pr & Human Resource Department.
- 7. Original Professional Degree, i.e. B.Ed. or B.S. Ed. Showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
