RECRUITMENT TO (02) POSTS OF EADA (E&M) PROJECT MANAGER (AMIS)/AGRICULTURE ECONOMIST / MARKETING SPECIALIST / PROGRAM COORDINATOR (BS-18) (INCLUDING 01 POST RESERVED FOR SPECIAL PERSON) ON CONTRACT BASIS FOR A PERIOD OF FIVE (05) YEARS IN ECONOMICS & MARKETING WING OF PUNJAB AGRICULTURE DEPARTMENT.

### **QUALIFICATION:**

- (i) M.Sc. (Hons) ("C" grade) in Agricultural Economics, Agricultural Marketing, Development Economics / Environmental and Resource Economics, OR MBA in Marketing and Agribusiness, OR MS (Management) specialization in Agribusiness OR MBA specialization in Agribusiness from a University recognized by the Higher Education Commission after obtaining B.Sc. (Hons) in Agriculture with major subjects of Agricultural Economics OR Marketing and Agribusiness;
- (ii) Two (02) years' Experience in agricultural economics **OR** agricultural marketing;
- (iii) B.Sc. (Hons) (four years) in Agricultural and Resource Economics **OR** BBA Agribusiness (four years) with five (05) years' experience in agricultural economics or agricultural marketing.

**AGE LIMIT:** Male Candidates: 21 to 35 + 05 = 40 Years

**Female Candidates:** 21 to 35 + 05 = 43 Years

**CLOSING DATE:** 01-09-2023

The following original documents are required for eligibility/scrutiny criteria for the subject

1. Valid CNIC (It must not be expired on last day of applying online.

- 2. Certificate of Matriculation/ O Level
- 3. Certificate of Intermediate/A. Level
- 4. Bachelor Degrees (mentioned above).
- 5. Master Degrees (mentioned above).
  - a. Candidates who do not possess said qualification will not be eligible even they had qualified Written Test / Examination.
  - In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Department)
  - c. DMCs of all above mentioned qualification showing Total and Obtained Marks / Percentage Certificate from Controller of Examination is required in case candidate have degree with only CGPA as PPSC does not accept CGPA).
- 6. Only Practical / Research Experience in line of Agricultural Economics or Agricultural Marketing containing detailed **Job duties.** 
  - a. Candidates who do not possess requisite experience (as mentioned in Advtt.) according the Service Rules will not be eligible even they had qualified written test / examination.
  - b. Experience will only be accepted when obtained after the prescribed qualification and before the closing date.
- 7. Domicile Certificate issued on or before the closing date.
- 8. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
