**GUIDANCE ON ELIGIBILITY / SCRUTINY CRITERIA**

SUBJECT: - **RECRUITMENT TO EIGHT (08) POSTS (INCLUDING 01 POST RESERVED FOR SPECIAL PERSON QUOTA AND 04 POSTS RESERVED FOR WOMEN QUOTA) OF CONSULTANT PAEDIATRICIAN (BS-18/PPG-13) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN THE PUNJAB EMPLOYEES SOCIAL SECURITY INSTITUTION (PESSI) LABOUR AND HUMAN RESOURCE DEPARTMENT(27M2023).**

**Qualification:**

MBBS or equivalent medical qualification recognized by the PMDC with postgraduate qualification of FCPS/MD/MRCP/FRCP (Paediatrics) / Diplomat of American Board, in the respective specialty, or equivalent medical qualification in the respective specialty recognized by PM&DC.

**OR**

MBBS or equivalent medical qualification recognized by the PMDC with postgraduate qualification of Diploma (02 years), DCH/MCPS (Paediatrics) or equivalent medical qualification in the respective specialty recognized by PM&DC with 02-years practical experience in the respective specialty after post-graduation in a recognized institution.

**Note:**

- i. Only practical Experience after the prescribed qualification shall be considered
- ii. Valid Permanent Registration Certificate from the Pakistan Medical & Dental Council (PMDC) / Pakistan Medical Commission (PMC) issued on or before the closing date for submission of online application is required.

**AGE LIMIT:** Male Candidate: 30 to 45+5=50 Years  
 Female Candidate: 30 to 45+8=53 Years

The following original documents are required for guidelines on eligibility criteria **OF CONSULTANT PAEDIATRICIAN (BS-18/PPG-13):-**

1. Original Valid CNIC **(It must not be expired on last day of applying online for the subject post).**
2. Original Certificate of Matriculation / O level showing date of birth Obtained/ Total Marks.
3. Original Certificate of Intermediate / A level showing Obtained/Total Marks.
4. Original Degree of MBBS including all professionals of MBBS Detailed Marks Certificate showing Obtained/Total Marks. Or Percentage Certificate issued by Competent Authority.
5. Original degree of FCPS/MD/MRCP/FRCP (Paediatrics) / Diplomat of American Board, in the respective specialty, or equivalent medical qualification in the respective specialty recognized by PM&DC.**OR**  
 MBBS or equivalent medical qualification recognized by the PMDC with postgraduate qualification of Diploma (02 years), DCH/MCPS (Paediatrics) or equivalent medical qualification in the respective specialty recognized by PM&DC.
  - a. Candidates who do not possess the above said qualification will not be eligible.
  - b. In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Interview from PMDC/PMC or QEDC of concerned Administrative Department.

- c. In case of experience gained from private entities, proof of registration of that particular entity with Pakistan Medical Commission / Pakistan Medical and Dental Council or any other regulatory authority is required for the period during which experience was gained by the candidate.

**Note:**

Two years Practical Experience in the respective specialty after post-graduation with the exact period of experience along with exact starting and ending date.

- a. Candidate who do not possess requisite experience as mentioned above according to the Service Rules will not be eligible.

6. Original Domicile Certificate issued on or before the closing date.
7. Departmental Permission Certification prescribed Performa of PPSC-5 duly issued by Appointing Authority in case of Government/Semi-Government employees/Autonomous bodies (if any).
8. i. Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.
- ii. In case of non-registration of post-graduate qualification with PMDC/PMC Registration Certificate on or before the closing date, applying proof for inclusion of such post-graduate registration is required issued/submitted on or before the closing date.
- iii. Candidates who had applied for renewal of their expired registration after the closing date shall also be held eligible.
9. Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
