**Subject:** **RECRUITMENT TO (09) POSTS OF DEPUTY DIRECTOR AGRICULTURE (OFWM) (BS-18+Rs.165/SP) (INCLUDING 01 POST RESERVED FOR SPECIAL PERSON QUOTA) ON CONTRACT BASIS FOR A PERIOD OF THREE (03) YEARS EXTENDABLE UPTO (05) YEARS IN THE WATER MANAGEMENT WING OF PUNJAB AGRICULTURE DEPARTMENT. (CASE NO. 76G2024)**

**QUALIFICATION:**

M.Sc. in Agricultural Engineering

**OR**

Master's degree in Water Engineering and Management

**OR**

M.Sc. (Hons) in Agriculture equivalent to eighteen years' education with following length of experience:

(i) 03 years' post qualification relevant experience in BS-18;

**OR**

(ii) 07 years' post qualification relevant experience in BS-17.

**Note:**

**Only Practical / Administrative Experience must be acquired after prescribed qualification**

**AGE LIMIT:**

**Male Candidates:**  $25 \text{ to } 35 + 05 = 40$  Years

**Female Candidates:**  $25 \text{ to } 35 + 08 = 43$  Years

**CLOSING DATE :**

The following original documents are required for eligibility/scrutiny criteria for the subject post.

1. **Valid CNIC (It must not be expired on last day of applying online.**
2. Certificate of Matriculation/ O Level
3. Certificate of Intermediate/A. Level
4. Bachelor degree
5. M.Sc. in Agricultural Engineering **or** Master's degree in Water Engineering and Management **or** M.Sc. (Hons) in Agriculture.
  - a. **Candidates who do not possess said qualification will not be eligible even they had qualified Written Test / Examination.**
  - b. **In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from QEDC of concerned Department)**
  - c. **DMCs of all above mentioned qualification showing Total and Obtained Marks / Percentage Certificate from Controller of Examination are required in case candidate have degree with only CGPA as PPSC does not accept CGPA).**
6. Only Practical / Administrative Experience in the relevant field containing detailed **Job duties.**
  - a. **Candidates who do not possess requisite experience (as mentioned in Advtt.) according the Service Rules will not be eligible even they had qualified written test / examination.**
  - b. **Experience will only be accepted when obtained after the prescribed qualification and before the closing date.**
7. Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the closing date of submission of applications for the subject post.
8. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
