QUALIFICATION:

(i) PhD. in Environmental Engineering or chemical Engineering or Environmental Sciences or Public Policy from a university recognized by Higher Education Commission;

- (ii) twelve years' experience in the relevant field from a public or private sector organization; and
- (iii) two publications in Reviewed Researched Journals recognized by Higher Education Commission; or
- (i) M.Phil. in Environmental Sciences or Public Policy from a university recognized by Higher Education Commission;
- (ii) Fifteen years' experience in the relevant field from a public or private sector organization; and
- (iii) Two publications in Reviewed Researched Journals recognized by Higher Education Commission; or
- (i) M.Sc. (Second division) In Environmental Engineering or chemical Engineering from a university recognized by Higher Education Commission;
- (ii) Seventeen years' experience in the relevant field from a public or private sector organization; and
- (iii) Two publications in Reviewed Researched Journals recognized by Higher Education Commission.

Note: Only Research or Practical experience must be acquired after prescribed qualification. Experience in private entities shall be accepted if such entity is registered with SECP, Registrar of firms or any other regulatory authority.
