 All bids must be accompanied by a Bid Security of 2% of the total bid price in the form of a CDR.

 The procurement will be conducted as per the <u>Single Stage – Two Envelope</u> Procedure in accordance with <u>Rule 38(2)(a)</u> of <u>Punjab Procurement Rules</u> 2014.

#### 7. Bid Validity:

· Bids shall remain valid for **90 days** from the date of bid opening.
