GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA

Subject:- **RECRUITMENT TO (191) ONE HUNDRED AND NINETY ONE (INCLUDING 16 POST RESERVED FOR SPECIAL PERSONS AND 10 POSTS RESERVED FOR MINORITY QOUTA) POSTS OF MEDICAL OFFICER (BS-17) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN THE (PUNJAB EMPLOYEES SOCIAL SECURITY INSTITUTION) PUNJAB LABOUR & HUMAN RESOURCE DEPARTMENT.**

PRESCRIBED QUALIFICATION OF THE POST:

MBBS with one year House Job duly recognized by PM&DC.

AGE LIMIT:- **Male:** 23 to 45 + 05 = 50 years

CLOSING DATE:-

The following original documents are required for eligibility/scrutiny criteria to the post of **Medical Officer (BS-17):-**

1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
2. Original Certificate of Matriculation /O Level showing date of birth Obtained/ Total Marks.
3. Certificate of Intermediate / A Level showing date of birth Obtained/ Total Marks.
4. Original Degree of MBBS including all professionals of MBBS Detailed Marks Certificate showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
 - a. Detailed Marks Certificates (DMCs) of all professionals of MBBS and relevant mentioned degree issued on or before the closing date showing obtained/total marks or Percentage Certificate from the Controller of Examinations is mandatory in case the candidates have degree with only CGPA as PPSC does not accept CGPA.
 - b. In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Interview from PMDC/PMC or QEDC of concerned Administrative Department.
5. One year house job duly recognized by PM&DC.
6. **i)** Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission issued on or before the closing date.
ii) Candidates who had applied for renewal of their expired registration after the closing date shall also be held eligible.
7. Domicile Certificate issued on or before the closing date.
8. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
9. Disability Certificate from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
