#### **GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA**

Subject:

RECRUITMENT TO 01 POST OF ASSOCIATE PROFESSOR OF PAEDIATRIC NEUROLOGY (BS-19) ON REGULAR BASIS IN THE PUNJAB SPECIALIZED HEALTHCARE & MEDICAL EDUCATION DEPARTMENT (19-RF/2024).

## **Prescibed Qualification of the Post:**

- i) MBBS or equivalent qualification recognized by the PMDC / PMC.
- ii)Registered with PMDC / PMC.
- ii) FCPS, MD, CCT, Diplomat American Board in Paediatric Neurology or equivalent qualification recognized by PMDC / PMC.

If no such candidate is available with the aforesaid qualification, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualifications recognized by the PMDC / PMC with one year experience in Paediatric Neurology after post graduation in Paediatrics obtained in a training program accredited by a National Body (CPSP or University) or an International Body recognized by the Pakistan Medical Commission:

And if no such candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualification recognized by the PMDC / PMC with two years experience in Paediatric Neurology after post-graduation in Paediatrics from an institute recognized by the PMDC / PMC.

- $(\mathrm{iv}) Five$  yearsteaching experience as Assistant ProfessorPaediatric Neurology from an institute recognized by PMDC / PMC; and
- (v) three research publications in Paediatric Neurology, as Assistant Professor published in a standard medical journal recognized by PMDC / PMC or the Higher Education Commission.

## **Age Limit till closing date:**

**Male Candidates:** 30 to 50 + 5 = 55 years**Female Candidates:** 30 to 50 + 8 = 58 years

The following **original documents** are required to determine the eligibility of the candidates for the posts of **ASSOCIATE PROFESSOR OF PAEDIATRIC NEUROLOGY(BS-19):-**

- 1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
- **2.** Original Certificate of Matriculation / O-level showing date of birth, obtained/total marks.
- **3.** Original Certificate of Intermediate / A-level showing obtained/total marks.
- **4.** Original all profs. Of BDS(ist to final) issued by the Controller of Examinations from the university recognized by the HEC.
  - **a.** Detailed Marks Certificates (DMCs)of all relevant mentioned degrees issued on or before the closing date showing obtained/total marksor Percentage Certificate from the Controller of Examinations is

mandatory in case the candidates have degree with only CGPA as PPSCdoes not accept CGPA.

- **b.** In case of equivalent qualifications, it will be responsibility of thecandidates to obtain equivalence of their degrees to the requiredqualification well before the conduct of Written Test / Interviewfrom HEC or QEDC of concerned Administrative Department.
- FCPS, MD, CCT, Diplomat American Board in Paediatric Neurology or equivalent qualification recognized by PMDC / PMCcompleted on or before the closing date of Advertisement.

If no such candidate is available with the aforesaid qualification, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualifications recognized by the PMDC / PMC with one year experience in Paediatric Neurology after post graduation in Paediatrics obtained in a training program accredited by a National Body (CPSP or University) or an International Body recognized by the Pakistan Medical Commission.

And if no such candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualification recognized by the PMDC / PMC with two years experience in Paediatric Neurology after post-graduation in Paediatrics from an institute recognized by the PMDC / PMC.

Experience Certificate(s) issued by Competent Authority as per requirement. (in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).

Only Teaching experience after the prescribed qualification shall be considered. In case of experience gained from private entities, proof of registration of that particular entity with Punjab Medical Commission / Punjab Medical and Dental Council or any other regulatory authority is required for the period during which experience was gained by the candidate. Experience gained on OPS (own pay & scale) shall not be accepted after 17-06-2021.

- **6.** Original Domicile Certificate of any district of the province of Punjab issued on or before the closing date.
- 7. Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.
- **8.** Five years teaching experience as Assistant Professor Paediatric Neurology from an institute recognized by PMDC / PMC; **and**three research publications in Paediatric Neurology, as Assistant Professor published in a standard medical journal recognized by PMDC / PMC or the Higher Education Commission.
- **9.** Acceptable Original Research Papers as described in qualification stated above.

- **10.** Departmental Permission Certificate on prescribed proforma of PPSC-5 duly signed & stamped by the Appointing / Competent Authority in case of Government Employees / Semi or Autonomous bodies.
- **11.** Equivalence Certificate of qualification from HEC / QEDC of the concerned Administrative Departmentas the case may be.
- **12.** Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
