ALTERATION OF SINGLE CABIN (HILUX 645B (867B) 4x2 S/C STD 2393CC) INTO 4 DOOR DOUBLE CABIN REVO

ELIGIBILITY CRITERIA FOR QUALIFICATION IN TENDER

- 1) The Punjab Public Service Commission, Lahore invites sealed bids from eligible bidders for Alteration of **Single Cabin (Toyota Hilux 645B (867B) 4x2 S/C STD 2393 CC)** into **4 Door Double Cabin Revo**, the said job is to be done from the manufacturers or their authorized dealers.
- 2) Bids should be submitted under the **PPRA Rule 38(2)(a), single stage two envelopes bidding method**, comprising a single package containing **two separate envelopes**. Each envelope shall contain separate technical proposal and financial proposal clearly mark as technical proposal and financial proposal in bold and legible letters. Details and specification's etc. are included in the standard bidding documents.
- 3) A complete set of bidding documents are immediately available in the office of the undersigned and the same may be obtained subject to the payment **@ Rs. 1000/-** as cost of printing and provision of the document tender fee to be deposited in favour of Secretary PPSC Lahore through **Challan No. 32-A** in head **C03-Miscellaneous Receipts, C038- Others, C03824-Others**. The Advertisement of the Tender is available on PPSC & PPRA'S website.
- 4) Financial bid's must be accompanied with a Bid Security / Earnest Money which is **2%** of the total offered bid value from the accounts of the bidder, in shape of Call Deposit Receipt (CDR) in favour of Secretary, Punjab Public Service Commission, Lahore.
- 5) Technical bids must be accompanied with an affidavit to the effect that **2%** earnest money, in shape of Call Deposit Receipt (CDR), is attached with the financial proposal, otherwise the technical proposal shall be considered non-responsive.
- 6) Bids must be delivered to the above office on or before **11.00 A.M.** on **26.02.2024** and will be opened in the presence of the bidders' representatives who choose to attend on the same day at **12.30 P.M.** in the Punjab Public Service Commission, Lahore.
- 7) The amount of performance security, as a percentage of the Contract Price, shall be **Ten (10%) percent** of the respective work order/s.
- 8) Firm/Company must have Registration with SECP.
- 9) Firms must be well established and financially sound to fulfill the task, and therefore, provide proof of previous successful supply of more than **Rs. 50 Million** to Government Departments of Same Product and at least **5 purchase** orders of Govt. Departments.
- 10) Participating firm must be registered with Chamber of commerce and Industries.
- 11) Participating firms must be registered as Manufacturer with Government / FBR authorities.
- 12) Participating firms must be **ISO 9001, OHSAS 18001, & ISO 45001 Certified**.
- 13) Relevant Brochure of 4 Doors converted from single cabin into double cabin must be attached.
- 14) Detail of plant and machinery with pictorial evidence.
- 15) Evidence of Hot Plate Welding Machine at factory.
- 16) Participating firms must have facilities of chromium Powder coating, Phosphating and Cadmium treatment of metal parts used in conversion.
- 17) Documentary proof of import of genuine parts shall be attached.
- 18) Detail of previous work experience and large scale supply must be enclosed.
- 19) Participating firms must have large market share and goodwill in the same field.
- 20) Participating firms must provide satisfactory performance certificate from the public sector organization(s).
- 21) Annual sales tax and income tax return for the last **3 years** may also be provided.
- 22) All the terms and conditions shall be fulfilled, failure of which will disqualify the participants.
- 23) The undersigned has the authority to accept or reject all/part of the tender without any reasons.
- 24) All conditions of **PPRA Rules 2014** will be applicable.
- 25) All Taxes of Government will be applicable otherwise exemption certification must be provided from the concerned authorities.
- 26) As per **PPRA Rule-35**, the undersigned reserves the right to reject any or all the bids/proposals at any time prior to the acceptance of a bid or proposal.
