## **GUIDANCE ON ELIGIBILITY / SCRUTINY CRITERIA**

RECRUITMENT AGAINST FIFTY THREE (53) (INCLUING ONE (01) POST RESERVED FOR SPECIAL PERSON QUOTA, THREE (03) POSTS RESERVED FOR MINORITY QUOTA, & NINE (09) POSTS RESERVED FOR WOMEN QUOTA) OF SYSTEM NETWORK ADMINISTRATOR (BS-17) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN PUNJAB IRRIGATION DEPARTMENT (CASE NO. 75–RG/2024)

### **PRESCRIBED QUALIFICATION OF THE POST:**

- i) Masters' degree (second division) in Computer Science or Information Technology or BCS (four years) (second division) in Computer Science or BS (second division) in Computer Systems Engineering or Computer Engineering or Software Engineering from an institute or university recognized by the Higher Education Commission;
- ii) Four years' post qualification experience in planning, designing, building and implementing network infrastructure solutions from public or private sector organization Development and management of the core information technology infrastructure and optimization of key processes related to use of the integrated systems. Design and operation of interfacing technologies such as networking, storage solutions, cloud computing and data center technologies. Design and operation of System or Network management Windows or Unix based server platforms; and
- iii) Hands-on experience with switches, routers, wireless, firewalls, load balancers, and other network-related appliances from private or public sector organization.

#### Note:

- i. Only practical experience acquired after prescribed qualification shall be considered.
- ii. Experience in private entities shall be accepted if such entity is registered with SECP, Registrar of firms or any other regulatory authority.

**Male Candidates:** 25 to 45 + 05 = 50 Years**Female Candidates:** 25 to 45 + 08 = 53 Years

**CLOSING DATE:** 15-08-2024

The following **original documents** are required to determine the eligibility criteria to the post of **SYSTEM NETWORK ADMINISTRATIOR (BS-17)**.

- i) Valid CNIC (It must not be expired on last day of applying online for the post i.e. SYSTEM NETWORK ADMINISTRATOR (BS-17).
- ii) Certificate of Matriculation/ O Level showing date of birth, obtained/total marks.
- iii) Original Certificate of Intermediate /A-level showing obtained /total marks.
- iv) Bachelor's degrees **as mentioned above in prescribed qualification of the post** including DMC showing Total and Obtained marks or percentage certificate issued by the Controller of Examination is required.
- v) Master's degrees (second division) **as mentioned above in prescribed qualification of the post** including DMC showing Total and Obtained marks or percentage certificate issued by the Controller of Examination is required.

- a. Candidates who do not possess the above said qualification will not be eligible even they had qualified Written Test / Examination.
- b. In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Department.
- c. Master's Degree or BS (four years), including DMCs showing Total and Obtained Marks or Percentage Certificate issued by the Controller of Examination is required in case a candidate has degree with only CGPA as PPSC does not accept CGPA.
- vi) Practical **Experience Certificate** must be acquired after prescribed qualification in planning, designing, building and implementing of network infrastructure solutions from public or private sector organization Development and management of the core information technology infrastructure and optimization of key processes related to use of the integrated systems. Design and operation of interfacing technologies such as networking, storage solutions, cloud computing and data center technologies. Design and operation of System or Network management Windows or Unix based server platforms; and Hands-on experience with switches, routers, wireless, firewalls, load balancers, and other network-related appliances from private or public sector organization containing detailed **Job duties/Job description field** with the exact period of experience, along with exact starting and ending date.
  - a. Candidates who do not possess requisite Practical experience as mentioned above according the Service Rules will not be eligible even they had qualified written test / examination.
  - b. Experience will only be accepted when obtained after the prescribed qualification and will be calculated till closing date of advertisement i.e. 15-08-2024. Experience gained from Private entities will only be accepted when that entity is registered with SECP or Registrar of Firms or with any other Regulatory Authority. Moreover, the candidate will provide the proof of registration of the firm/company from SECP or Registrar of Firms or any other Regulatory Authority for the specific period of his experience.
- vii) Domicile Certificate issued on or before the closing date.
- viii) Departmental Permission Certificate issued from Appointing Authority in case of Government employee.
- ix) Equivalence Certificate of qualification from HEC / QEDC of concerned Administrative Department as the case may be.
- x) In case of claim of Special Person Quota, Disability Certificate issued by the Social Welfare Department is required.
