- 3) The bidders are required to give their best and final prices (inclusive of all applicable Taxes & duties etc.), as negotiations are not allowed.
- 4) Taxes will be deducted as per applicable government rules. Bid Security, NTN and Sales Tax registration certificate and tender fee deposit slip must be provided with the Technical Bid.
- 5) Bids, which are incomplete, not sealed, not signed and / or not stamped, late or submitted by other than specified mode, shall be rejected.
