# **GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA**

## Subject:- RECRUITMENT TO ONE (01) POST OF DEPUTY NURSING SUPERINTENDENT (BS-17) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN THE PUNJAB EMPLOYEES SOCIAL SECURITY INSTITUTION (PESSI) LABOUR AND HUMAN RESOURCE DEPARTMENT (CASE NO.37M2023).

## **QUALIFICATION:**

- i) M.Sc Nursing or equivalent qualification from recognized University **OR**
- ii) B.Sc Nursing post registered nurse **OR**
- iii) B.Sc Nursing generic and one year specialized diploma in any discipline (preferably Nursing Management or ward administration **OR**
- iv) Registered Nurse and registered midwife with:-
- a) Diploma in Nursing management or ward administration.
- **b)** Preference will be given to registered nurse with additional diploma of nursing education or teaching administration or equivalent qualification registered with Pakistan Nursing Council
- v) In additional to all above qualification, valid registration from the Pakistan Nursing Council.

### Important Note:-

- i. The candidates who had applied to PNC for Registration of their Diplomas, B.Sc. Nursing Generic, B.Sc. Post-Registered or M.Sc. Nursing or on or before the closing date but;
  - **a.** Registration Cards were issued after the closing date; or
  - **b.** Registration cards have not been issued so far;
- **ii.** Shall be Provisionally held eligible subject to the condition that such candidates shall have to produce documentary evidence properly stamped & signed by the Competent Authority of PNC that they have applied for such card on or before the closing date.
- **iii.** The candidates who had applied to PNC for renewal of their expired registration card after the closing date shall also be held eligible.

#### **AGE LIMIT:-** Female Candidates: 25 to 35+ 8 =43 year

#### **CLOSING DATE:-**

The following original documents are required for eligibility/scrutiny criteria to the post of **DEPUTY NURSING SUPERINTENDENT (BS-17)** :-

- 1. Valid CNIC
- 2. Certificate of Matriculation / O Level (Equivalence Certificate from IBCC)
- 3. Certificate of Intermediate / A Level (Equivalence Certificate from IBCC)
- 4. M.Sc. Nursing or equivalent qualification from a recognized **OR**
- 5. B.Sc. Nursing Post Registered Nurse **OR**
- 6. B.Sc Nursing generic and one year specialized diploma in any discipline (preferably Nursing Management or ward administration **OR**
- 7. Registered Nurse and registered midwife with:-
- 8. Diploma in nursing management or ward administration.

**a**. Candidates who do not possess the above said qualification will not be eligible even they had qualified the written test.

**b.** In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Department.

#### From Pre-page:-

- **c.** Bachelor's Degree (04 Years) or Master's Degree including DMCs showing Total and Obtained Marks / Percentage Certificate from Controller of Examination is required in case candidate have degree with only CGPA as PPSC does not accept CGPA.
- 9. Valid Registration from Pakistan Nursing Council.
- 10. Domicile Certificate issued on or before the closing date.
- 11. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
- 12. Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
