 - (ii) No more candidate is available amongst children of Govt. servants of BOR upto junior clerk in service/retired. Therefore, as per notification No.SOR-III(S&GAD)2-74/2008 dated 21-08-2009, three (03) posts reserved for children of Govt. servants of BOR upto junior clerk in service/retired shall be treated as unreserved and filled on merit.
 - (iii) Eighteen (18) (including 04 posts reserved for minorities quota, 02 posts reserved for special persons quota and 12 posts reserved for children of Govt. servants of BOR upto Junior Clerk in service/retired) posts remained vacant due to non-availability of candidates.
