### **NOTICE**

In continuation to earlier notice dated 30-05-2024, the Punjab Public Service Commission announces that 10 candidates had been shortlisted for interview. The said candidates were asked to submit their documents for scrutiny within seven days. Out of those candidates, documents of only one (01) candidate were received which were scrutinized and he was found ineligible. All ten (10) candidates were issued final rejection letters on 25-06-2024.
