Prescribed Qualification

- (i) MBBS or equivalent qualification recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council;
- (ii) Registered with Pakistan Medical Commission/Pakistan Medical & Dental Council ;
- (iii) FCPS, MD, CCT, Diplomat of American Board in Neonatology or equivalent qualification recognized by the Pakistan Medical Commission/Pakistan Medical & Dental Council.
If no candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualifications recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission with one year experience in Neonatology after Post-graduation in Paediatrics obtained in a training program accredited by a national body (CPSP or university) or an international body recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission.
And if no such candidate is available with the aforesaid qualifications, then FCPS (Paediatrics), MD (Paediatrics), MRCPCH, Diplomat American Board of Paediatrics or equivalent qualifications recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission with two years' experience in Neonatology after Post-graduation in Paediatrics from an institute recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission;
- (iv) Three years' experience as an Associate Professor Neonatology or an equivalent position provided that the total teaching experience as an Assistant or an Associate Professor in Neonatology is not less than eight years from an institute recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission or nine years' teaching experience as an Assistant or Associate Professor in Neonatology from an institute recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission; and
- (v) Five research publications in Neonatology, while working as an Assistant or Associate Professor published in a standard medical journal recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission or the Higher Education Commission.

Equivalent Qualifications, If any:

As recognized by the Pakistan Medical & Dental Council (PMDC)

Age Limit: Male: 30 to 50 + 5 = 55 years

Female: 30 to 50 + 8 = 58 years

The following **original documents** are required to determine the eligibility of the candidates for the subject post(s):-

- ii. Original Departmental Permission Certificate issued by the Appointing Authority (in case of government employees).
- iii. Matriculation Certificate indicating Total/obtained Marks & D.O.B/School leaving Certificate showing D.O.B.
- iv. Intermediate Certificate indicating Total/obtained Marks.

- v. MBBS (First to Final Professional) showing obtained/total marks or equivalent Medical qualifications recognized by PMDC/PMC.
- vi. Postgraduate degree in the relevant specialty / equivalent qualification or its Election letter showing specialty as per advertisement.
- vii. Valid full (Permanent) Registration Certificate of PMDC/PMC showing all Medical Qualification(s).
- viii. Domicile Certificate of any district of the Punjab Province, issued on or before the closing date of Advertisement.
- ix. Experience Certificate(s) issued by Competent Authority as per requirement.
(in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).
- x. Recognition of experience certificate issued by PMDC.
- xi. Disability Certificate (in case of Specially-abled Person)
- xii. Equivalence Certificate issued by the Competent Authority (in case of possessing an equivalent qualification)
- xiii. Acceptable Original Research Papers as described in qualification stated above.
