- 2) Public auction will be held **at 1100 hours on 17-04-2023** at Punjab Public Service Commission (Old Building) 02- Davis Road, Lahore by PPSC designated Auction Committee in presence of eligible Bidders. Bidders will provide copy of their valid CNIC, complete address, email and telephone/mobile, cell numbers.
- 3) The Window Air Conditioners (Lot #01) shall be auctioned on "Lump-sum" rate basis. Iron Scrap (Lot # 02) shall be auctioned on "Per Kg" rate basis. Wooden Chairs / Wooden Tables etc. (Lot#03) shall be auctioned on "Per Kg" rate basis. Computer Equipment's (Lot#04) and Miscellaneous dead stock items (Lot#05) shall be auctioned on "Per Kg" rate basis. Tyres at Lump Sump rate basis.
- 4) Pay Order/Demand Draft amounting to Rs. 25,000/- (Rupees Twenty Five Thousand only) in favour of Secretary, Punjab Public Service Commission, Lahore as Expression of Interest/token money will be deposited by the participant along with copy of valid CNIC. No person shall be allowed to participate in public auction without depositing such token money in the shape of Pay Order/Demand Draft.
- 5) Successful/highest bidder(s) shall have to deposit 25% of the highest bid amount at the spot for each Lot as earnest money (Non Refundable), failing which the bid shall be rejected, token money of the bidder shall be forfeited and such Lot shall be presented again for auction at the end.
- 6) The successful/highest bidder shall deposit the remaining bid amount within 02 (Two) days after approval of the bid by the competent authority, otherwise, 5% of bid amount shall be charged as ground rent up-to the period of 10 days and thereafter the whole amount will be forfeited.
- 7) Government Taxes (whatsoever admissible) will be charged as per prevailing Punjab Government Rules, besides Bid Price separately.
- 8) The successful/highest bidder shall be permitted to take auctioned scrap/dead stock items at his own cost/expense after submission of full payment including all taxes.
- 9) PPSC reserves the right to accept or reject any or all bids and to add or withdraw any scrap/dead stock item before Public auction.
- 10) In case of any dispute, the decision of Auction Committee shall be the final and will not challengeable in any court of Law. Queries (if any) can be cleared at the spot, thereafter, no objection shall be entertained and decision of Auction Committee shall be final.
