GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA

Subject: **RECRUITMENT TO TWO (02) POSTS OF ASSOCIATE PROFESSOR OF PAEDIATRIC CARDIAC SURGERY/PAEDIATRIC CARDIOVASCULAR SURGERY (BS-19) ON REGULAR BASIS IN THE PUNJAB SPECIALIZED HEALTHCARE & MEDICAL EDUCATION DEPARTMENT.**

Prescribed Qualification of the Post:

- (i) MBBS or equivalent qualification recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission with post-graduate qualification of FCPS or MS or FRCS or Diplomate American Board or equivalent qualification in Paediatric Cardiac or Paediatric Cardiovascular or Congenital Cardiac Surgery recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission.

If none is available with the above mentioned qualifications then:

MBBS or equivalent qualification recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission with post-graduate qualification of FCPS or MS or FRCS or Diplomate of American Board or equivalent qualification recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission in:

- (a) Cardiac or Cardiothoracic or Cardiovascular Surgery with four years' experience, after post-graduation in Paediatric Cardiac Surgery or Paediatric Cardiovascular Surgery from an institution recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission; **or**
- (b) Paediatric Surgery or General Surgery with six years' experience, after post-graduation, in the Paediatric Cardiac Surgery or Paediatric Cardiovascular Surgery from an institution recognized by Pakistan Medical & Dental Council/Pakistan Medical Commission; **and**
- (ii) Five years' teaching experience as Assistant Professor Paediatric Cardiac Surgery/Paediatric Cardiovascular Surgery from an institution recognized by the Pakistan Medical & Dental Council/Pakistan Medical Commission; **and**
- (iii) Three research publications in the relevant Paediatric Surgery specialty as Assistant Professor.

Note: An original article published in a medical journal approved by the Pakistan Medical Commission shall only be considered and dissertation or thesis shall not be counted.

Equivalent Qualifications, If any:

As recognized by the Pakistan Medical Commission (PMC).

Age Limit till closing date:

Male: 30 to 50 + 5 = 55 years

Female: 30 to 50 + 8 = 58 years

The following **original documents** are required to determine the eligibility of the candidates for the subject post:-

- i. Valid CNIC
- ii. Original Departmental Permission Certificate issued by the Appointing Authority.
- iii. Matriculation Certificate indicating Total/obtained Marks & D.O.B/School leaving Certificate showing D.O.B.
- iv. Intermediate Certificate indicating Total/obtained Marks.

P.T.O

- v. MBBS (First to Final Professional) showing obtained/total marks or equivalent Medical qualifications recognized by PMC.
- vi. Postgraduate degree in the relevant specialty / equivalent qualification or its Election letter showing specialty as per advertisement.
- vii. Valid full (Permanent) Registration Certificate of PMDC/PMC showing all Medical/Dental Qualification(s).
- viii. Domicile Certificate of any district of the Punjab Province, issued on or before the closing date.
- ix. Experience Certificate(s) issued by Competent Authority as per requirement. (in case of Punjab Government employee of Health Department, the Experience Certificate must be issued by Competent Authority of Health Department).
- x. Disability Certificate (in case of Special Person)
- xi. Equivalence Certificate issued by the Competent Authority (in case of possessing an equivalent qualification)
- xii. Acceptable Original Research Papers as described in qualification stated above.
