## **QUALIFICATION:**

M.A./M.Sc. with B.Ed. or B.S. Ed.

For SSTs (Math), M.Sc. in relevant subject.

1. Only those degrees which are recognized by Higher Education Commission will be accepted.

2. At least 2<sup>nd</sup> Division in the prescribed minimum qualifications is required.

Female: 21 to 35+ 8 = 43 years

The following original documents are required for eligibility/scrutiny criteria to the of **SST (Math) (BS-16):-**

- 1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
- 2. Original Certificate of Matriculation / O level showing date of birth Obtained/ Total Marks.
- 3. Original Certificate of Intermediate / A level showing Obtained/Total Marks.
- 4. Original Bachelor Degree showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
- 5. Original M.Sc. degree (2<sup>nd</sup> Division) or BS (2<sup>nd</sup> division) in the relevant subject showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
  - 6. Candidates who do not possess the above said qualification will not be eligible even they had qualified Written Test.
  - b. In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Administrative Department. However, a list of equivalent qualifications is available on the Commission's official website, provided by the Labour & Human Resource Department.
- 7. Original Professional Degree, i.e. B.Ed. or B.S. Ed. Showing Obtained/Total Marks or Percentage Certificate issued by Competent Authority.
