**GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA**

**Subject: RECRUITMENT TO (03) THREE POSTS OF ASSISTANT PROFESSOR PAEDIATRIC NEUROSURGERY (BS-18) ON REGULAR BASIS IN THE PUNJAB SPECIALIZED HEALTHCARE AND MEDICAL EDUCATION DEPARTMENT. (CASE NO. 3E2024).**

**Prescribed Qualification of the Post:**

- (a) MBBS or equivalent qualification recognized by the PMDC/PMC.
- (b) Registered with PMDC/PMC.
- (c) The following postgraduate qualification:
- (i) FCPS/MS/FRCS/Diplomat American Board in Paediatric Neurosurgery or equivalent qualification recognized by PMDC/PMC.
- OR**
- (ii) FCPS/MS/FRCS/Diplomat American Board or equivalent qualification recognized by PMDC/PMC in Paediatric Surgery/General Surgery with one year (practical) Experience after Post graduation in Paediatric Neurosurgery in an institution recognized by PMDC/PMC.
- OR**
- (iii) FCPS/MS/FRCS/Diplomat American Board or equivalent qualification recognized by PMDC/PMC & Govt. of the Punjab in Neurosurgery with one year (practical) Experience after Post graduation in Paediatric Neurosurgery in an institution recognized by PMDC/PMC.
- (d) Three years (practical) Experience after Post graduation in Paediatric Neurosurgery in an institution recognized by PMDC/PMC.

**Note:**

- (i) **Only Practical Experience after the prescribed qualification shall be considered.**
- (ii) **Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.**

**Age Limit till closing date:**

**Male Candidates:** 25 to 45 + 5 = 50 years

**Female Candidates:** 25 to 45 + 8 = 53 years

The following **original documents** are required to determine the eligibility of the candidates for the post of **ASSISTANT PROFESSOR PAEDIATRIC NEUROSURGERY (BS-18):-**

- 1.** Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
- 2.** Original Certificate of Matriculation / O-level showing date of birth, obtained/total marks.
- 3.** Original Certificate of Intermediate / A-level showing obtained/total marks
- 4.** Original All Prof. of MBBS issued by the Controller of Examinations from the university recognized by the HEC.
  - a.** Detailed Marks Certificates (DMCs) of all relevant mentioned degrees issued on or before the closing date showing obtained/total marks or Percentage Certificate from the Controller of Examinations is mandatory in case the candidates have degree with only CGPA as PPSC does not accept CGPA.

b. In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Written Test / Interview from HEC or QEDC of concerned Administrative Department.

5. **Original Degree / Election letter of FCPS or MS or FRCS or Diplomat of American Board in the respective speciality i.e. Paediatric Neurosurgery or equivalent medical qualification in the respective speciality i.e. Paediatric Neurosurgery from an institute or University recognized by the PMDC/PMC, showing result notification date declared on or before the closing date, along with three years' original practical experience certificate after post-graduation in Paediatric Neurosurgery from an institute recognized by PMDC/PMC.**

**OR**

**Postgraduate qualification of FCPS, MS, FRCS, Diplomat of American Board or equivalent qualification in Paediatric Surgery / General Surgery recognized by PMDC/PMC showing result notification date declared on or before the closing date, with four years' original practical experience certificate after post-graduation in the respective speciality i.e. Paediatric Neurosurgery.**

**OR**

**Postgraduate qualification of FCPS, MS, FRCS, Diplomat of American Board or equivalent qualification in Neurosurgery recognized by PMDC/PMC showing result notification date declared on or before the closing date, with four years' original practical experience certificate after post-graduation in the respective speciality i.e. Paediatric Neurosurgery.**

6. Original Domicile Certificate of any district of the province of Punjab issued on or before the closing date.
7. In case of experience gained from private entities, proof of registration of that particular entity with Punjab Medical Commission / Punjab Medical and Dental Council or any other regulatory authority is required for the period during which experience was gained by the candidate.
8. i. Valid (full) Permanent Registration Certificate from the Pakistan Medical and Dental Council / Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.
- ii. In case of non-registration of post-graduate qualification with PMDC/PMC Registration Certificate on or before the closing date, applying proof for inclusion of such post-graduate registration is required issued/submitted on or before the closing date.
- iii. Candidates who had applied for renewal of their expired registration after the closing date shall also be held eligible.
9. Departmental Permission Certificate on prescribed proforma of PPSC-5 duly signed & stamped by the Appointing / Competent Authority in case of Government Employees / Semi or Autonomous bodies.

- 10.** Equivalence Certificate of qualification from HEC / QEDC of the concerned Administrative Department as the case may be.
- 11.** Disability Certificate (in case of Special Person) from the Provincial Council for Rehabilitation of Disabled Persons of Social Welfare Department issued on or before the Closing Date of submission of applications for the subject post.
