The result of nine (09) posts reserved for special zone quota have been withheld by PPSC due to judgment dated 11-06-2019 of Hon'ble Lahore High Court, Lahore in writ petition No. 257665/2018 titled as Dr. Shahbaz Mujtaba Ghauri vs ppsc etc. However, an I.C.A No. 39525/2019 filed by Dr. Anees ur Rehman against the said judgment is pending adjudication in Division Bench of Lahore High Court, Lahore. The said result will be announced after the final outcome of the aforementioned I.C.A.

- ii) Three (03) (including 01 post reserved for special persons quota and 02 posts reserved for minorities quota) posts remained vacant due to non-availability of suitable candidates.
- iii) Seven female candidates are available against the six (06) posts reserved for women quota for above said posts. Six (06) female candidates were selected against open merit and one (01) female candidate selected against women quota. Therefore, as per notification No.SOR-IV(S&GAD)15-1/2012 dated 21-05-2012, **five (05)** posts reserved for Female quota shall be treated as unreserved and filled on merit.
