### **NOTICE**

In continuation to earlier notice dated 11-01-2023, the Punjab Public Service Commission announces that 05 candidates qualified the written test and were called for interview. Out of which two (02) candidates remained absent, two (02) candidates were rejected as they did not possess requisite experience and one (01) candidate was interviewed provisionally on account of deficient documents. However, upon submitting the deficient documents and subsequent scrutiny, the candidature of the candidate was declared cancelled. Therefore, in the light of PPSC Policy Decisions – 2016 [P.D.17.8 (a)] the following next **05** available candidates in the merit list for recruitment to **01 POST OF ASSISTANT DIRECTOR (I.T SOFTWARE) (BS-17) ON CONTRACT BASIS FOR THE PERIOD OF THREE (03) YEARS.
