**QUALIFICATION:**

- i. LLB from a University recognized by Higher Education Commission having three years' experience of active practice after enrollment as Advocate.

**Note:**

- i. Only Practical Experience shall be considered after prescribed qualification.
- ii. Candidates must have Membership of concerned Bar Counsel issued on or before the closing date.
- iii. Experience certificate showing exact dates & containing complete information from President District Bar Association/Sub Divisional Bar Association duly countersigned and affixing rubber stamp of District and Session Judge/Additional District & Session Judge concerned (in original) also having membership shall be submitted at the time of Interview.

**The following original documents are required for eligibility of the said post:-**

1. Original Valid CNIC (it must not be expired on last day of applying online for the said posts).
2. Certificate of Matriculation/ O Level showing date of birth, obtained/total marks.
3. Certificate of Intermediate/A Level showing obtained/total marks.
4. Bachelor's Degree/Transcript/DMC showing total marks & Obtained marks/ percentage of marks issued by the controller of Examination.
5. LLB from a University recognized by Higher Education Commission having three years' experience of active practice after enrollment as Advocate.
6. Candidates who do not possess the above said qualification will not be eligible even they had qualified Written Test.
  - a. DMCs showing Total and Obtained Marks/Percentage Certificate from Controller of Examination is required if candidate have degree with only CGPA as PPSC does not accept CGPA.
  - b. Only Practical experience is acquired after prescribed qualification.
  - c. Candidates must have Membership of concerned Bar Counsel issued on or before the closing date.

- d. Experience certificate showing exact dates & containing complete information from President District Bar Association/Sub Divisional Bar Association duly countersigned and affixing rubber stamp of District and Session Judge/Additional District & Session Judge concerned (in original) also having membership shall be submitted at the time of Interview.
7. Domicile Certificate issued on or before the closing date.
8. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
9. Disability certificate duly issued / verified by Social Welfare Department (if applicable) issued on or before the closing date of submission of applications for the subject post.
