ELIGIBILITY/ SCRUTINY CRITERIA

RECRUITMENT TO 43 POSTS OF COMBINED COMPETITIVE EXAMINATION - 2023 IN THE SERVICES & GENERAL ADMINISTRATION DEPARTMENT

QUALIFICATION:

Graduate Degree (Second Division) from a recognized University.

AGE LIMIT:

For Male / Female / Special Persons Candidates:

21 to 30 years on 1st January 2024. In the case of officials serving in connection with the affairs of the Federal Government, who are domiciled in the Punjab as well as the officials serving in connection with the affairs of the Punjab Government having at least 4 years service as such, the upper age limit shall be 35 years. For special persons, maximum 15 years relaxation in upper age limit shall be allowed as per Punjab Civil Servants Recruitment (Relaxation of Upper Age Limit) Rules, 1976.

IMPORTANT NOTE

- The relaxation as per Government of the Punjab, S&GAD Notification No. SOR-III(S&GAD)1-25/94(P) dated 29- 11-2012, Punjab Delegation of Powers (Relaxation of Age) Rules, 1961 shall not apply to the posts of the Government required to be filled through Combined Competitive Examination conducted by the Punjab Public Service Commission.
- ii) Employees of Semi Government and Autonomous Bodies of Federal Government or Provincial Government and those of Local Bodies are not entitled to age concession for the period of their service in such organization.

The following original documents are required for eligibility to the post of COMBINED COMPETITIVE EXAMINATION - 2023

Valid CNIC.

- Matriculation Certificate/O Level.
- Intermediate Certificate/A Level/ F.A/ Fsc/ I.com / D.com/ I.C.S
- Bachelor degree BA / B.Sc (2 Years) / B.S / B.Sc (Hons) (4 Years).
- Domicile Certificate of any District of Province of Punjab issued on or before the closing date or proof of application for issuance of domicile before closing date.
- Departmental Permission Certificate issued from Appointing Authority in case of Government employees.
- Equivalence Certificate of qualification from HEC/ QEDC of concerned Administrative Department in case earned qualification of the aspirant needs to be equated with Graduation (2nd Division) in Pakistani Universities.
- Experience Certificate showing 4 years' service in Punjab Government / Federal Government as the case may be.
- Valid Disability Certificate issued by Punjab Council for the Rehabilitation of the Disabled Persons on or before the closing date (for claiming of Age Relaxation).
