 - i. FCPS/MS/FRCS/Diplomat American Board in Paediatric Urology or equivalent Qualification recognized by the PMDC/PMC.
OR
 - ii. FCPS/MS/FRCS/Diplomat American Board or equivalent Qualification recognized by PMDC in Pediatric Surgery/General Surgery with one year experience after post graduation in Pediatric Urology in an institution recognized by the PMDC/PMC.
OR
 - iii. FCPS/MS/FRCS/Diplomat American Board or equivalent Qualification recognized by the PMDC/PMC and Govt. of the Punjab, in Urology with one year experience after post graduation in Pediatrics Urology in an institution recognized by the PMDC/PMC.
- iv) Five years experience as Assistant Professor in relevant Specialty in an institute recognized by the PMDC/PMC.
- v) With at least three research papers published in a medical journal recognized by the PMDC/PMC while working as Assistant Professor.
