**GUIDELINES ON ELIGIBILITY / SCRUTINY CRITERIA**

Subject:- **(CASE NO.42-RD/2022) RECRUITMENT TO ONE (01) POSTS OF SENIOR REGISTRAR PAEDIATRIC DERMATOLOGY (BS-18) ON REGULAR BASIS IN THE SPECIALIZED HEALTHCARE & MEDICAL EDUCATION DEPARTMENT.**

**QUALIFICATION:**

- a) MBBS or equivalent qualification recognized by the PMDC/PMC.
- b) Registered with PMDC/PMC.
- c) The following Postgraduate Qualification:
  - i. FCPS/MD/MRCP/Diplomat American Board in Paediatric Dermatology or equivalent qualification recognized by PMDC/PMC.

**OR**
  - ii. FCPS (Derm.)/MD(Derm.)/MRCP(Derm.)/Diplomat American Board(Derm.) or equivalent qualification recognized by PMDC/PMC with one year experience after post-graduation in Paediatric Dermatology in an institution recognized by PMDC/PMC.

**OR**
  - iii. FCPS (Paediatrics) / MD (Paediatrics) / MRCP (Paediatrics) / Diplomat American Board (Paediatrics) or equivalent qualification recognized by PMDC/PMC with one year experience after post graduation in Paediatric Dermatology in an institution recognized by PMDC/PMC.

**AGE LIMIT:-** **Male Candidates:** 25 to 45+ 7 = 52 Years

**Female Candidates:** 22 to 45+ 10 = 55 Years

The following original documents are required for eligibility/scrutiny criteria to the post of **Senior Registrar Paediatrics Dermatology (BS-18):-**

1. **Valid CNIC (It must not be expired on last day of applying online for the post i.e. 16-01-2023)**
2. Certificate of Matriculation / O Level (Equivalence Certificate from IBCC)
3. Certificate of Intermediate / A Level (Equivalence Certificate from IBCC)
4. MBBS or equivalent qualification recognized by the PMDC/PMC.
5. The following Postgraduate Qualification:

FCPS/MD/MRCP/Diplomat American Board in Paediatric Dermatology or equivalent qualification recognized by PMDC/PMC.

**OR**

FCPS (Derm.)/MD(Derm.)/MRCP(Derm.)/Diplomat American Board(Derm.) or equivalent qualification recognized by PMDC/PMC with one year experience after post-graduation in Paediatric Dermatology in an institution recognized by PMDC/PMC.

**OR**

FCPS (Paediatrics) / MD (Paediatrics) / MRCP (Paediatrics) / Diplomat American Board (Paediatrics) or equivalent qualification recognized by PMDC/PMC with one year experience after post graduation in Paediatric Dermatology in an institution recognized by PMDC/PMC.
- a. **In case of equivalent qualifications, it will be responsibility of the candidates to obtain equivalence of their degrees to the required qualification well before the conduct of Interview from HEC or QEDC of concerned Department.**
6. Valid (full) Permanent Registration Certificate from the PMDC/Pakistan Medical Commission showing post-graduate qualification issued on or before the closing date.
7. Experience Certificate containing detailed **Job Duties** including one years' post-graduation practical experience in the respective specialty from a recognized institute. **(For qualification Serial No. c(ii) & c(iii))**

**P.T.O**

- a. Candidates who do not possess requisite practical experience as mentioned above according to the Service Rules will not be eligible.
- b. Experience will only be accepted when obtained after the prescribed highest qualification and before the closing date.

**The candidates who had applied to PMDC/PMC for full Registration of their Post-graduate qualification on or before the closing date but;**

- i. **PMDC/PMC Registration Certificates were issued after the closing date; or**
- ii. **PMDC/PMC Registration Certificates have not been issued so far;**

**“May be held eligible subject to the condition that such candidates shall have to produce documentary evidence properly stamped & signed by the Competent Authority of PMDC/PMC that they have applied for such registration on or before the closing date”.**

- iii. **The candidates who had valid PMDC/PMC Registration on or before closing date but their registration has expired on or before the date of interview and they had applied to PMDC/PMC for renewal of their expired registration after the closing date shall be held eligible. However, if a candidate had expired registration on or before the closing date and he had to apply to PMDC/PMC for renewal of his expired PMDC/PMC registration after the closing date shall not be held eligible.**

**8. Domicile Certificate issued on or before the closing date.**

**9. Departmental Permission Certificate issued from Appointing Authority in case of Government employees.**

**10. Equivalence Certificates of qualification from HEC / QEDC of concerned Administrative Department as the case may be.**

**11. Disability Certificate (in case of Special Person).**
